WHEREAS the 2024-25 Hospital Service Accountability Agreement (HSAA) signed between Bruyère Continuing Care and Ontario Health East on March 28, 2024 took effect on April 1, 2024;

WHEREAS on March 27, 2024, OHE approved our request of a Balanced Budget Waiver (BBW) for Fiscal Year 2023-24;

WHEREAS on February 14, 2025, OHE confirmed the 2023-24 BBW is still in place and given the 2024-25 financial results doesn't need to be updated;

WHEREAS pursuant to Article 8.6.2 of the HSAA the Board is required to attest to the fulfilment of its obligations under the agreement;

WHEREAS the President and CEO has provided a compliance attestation that includes some exceptions for the period of April 1, 2024 to March 31, 2025;

WHEREAS at its meeting held on May 5, 2025, ARMC received all supporting documentation as to the compliance attestation provided by the President and CEO;

WHEREAS ARMC members reviewed the elements of the Hospital Service Accountability Agreement Compliance Attestation and were satisfied with the documentation provided; and

WHEREAS members were satisfied with the compliance attestation from the President and CEO.
